Growing Up in Australia: The Longitudinal Study of Australian Children is conducted as a partnership between the Department of Social Services (DSS), the Australian Institute of Family Studies (AIFS) and the Australian Bureau of Statistics (ABS), with advice provided by a consortium of leading researchers.

⋮ How is the data used?

Growing Up in Australia is an ongoing study with information collected using a variety of methods including paper forms, online, telephone and face-to-face interviews.

The purpose of the Study is to provide data that enables a comprehensive understanding of development and life course trajectories within Australia's current social, economic and cultural environment. The Study gives policy-makers and researchers access to quality data and is used to help the government plan future policies and services.

Data collected is also used by Australian and International researchers from various fields of study and compared with data from similar longitudinal studies conducted in other countries.

⋮ Introduction to privacy

Your privacy is very important to us. Strict procedures are followed to ensure that only authorised people have access to the information provided to us and that all interviewers, researchers and others involved in the Study comply with the *Privacy Act 1988*.

Growing Up in Australia collects a range of information from you, including personal and sensitive information. Personal information is defined as any information or opinion about an identified individual. Of this, any details relating to race, ethnicity or health are considered sensitive. Basic information about you may be collected from the other members of your family/household who have been asked to participate in a *Growing Up in Australia* survey. This information collected about you may include details of relationships, caring roles, COVID-19 impacts, and financial support. This enables us to better understand the situation that Study participants are living in.



Growing Up in Australia data

The ABS is collecting *Growing Up in Australia* information under the authority of the *Australian Bureau of Statistics Act 1975*. Information is collected from various informants including the young person and parents and/or guardians of the young person. Any informant may choose to not take part, discontinue participation at any time, or not answer particular questions. Information collected by the ABS for the *Growing Up in Australia* study is collected on a voluntary basis and will only be used for:

- Statistical purposes; and
- Maintaining contact with study participants for the purposes of the Study.

Data released to partner agencies, researchers and policy makers is de-identified (i.e. excludes names and addresses) and data from all participants is combined before being published. Strict procedures are followed by all partner agencies to ensure that all information collected is kept strictly confidential. Data from the Study is securely stored at the Australian Data Archives.

If the organisation responsible for future data collection phases of the Study changes, the ABS will be required to disclose your information to that organisation.

Provision of information is voluntary and where consent is withdrawn, *Growing Up in Australia* will no longer collect data from the person withdrawing. Where consent for data linkage has previously been provided, participants must explicitly notify the Study if they wish to withdraw their consent to any further release of their linked data. Data previously released to researchers will continue to be used and form part of the *Growing Up in Australia* study.
